Dr Ray Choy

Dr Ray Choy is Chief Economist at MARC Ratings Berhad. Prior to MARC, he headed the research offices of banking groups CIMB and RHB across Southeast Asia, following a leadership role in global funds management, accumulating over two decades of experience. Dr Ray has earned top rankings by Alpha Southeast Asia, The Asset, and Lipper, among others. He has published in top-tier, peer-reviewed journals and authored "Essays in Bond Market Economics".

Additionally, he is a corporate trainer, an adjunct academic at Monash University, and was admitted to the Directors' Registry of the Institute of Corporate Directors Malaysia. Dr Ray holds a BA in Business and Finance (Distinction) from Heriot-Watt University, a BSc in Politics and International Relations (1st Class Honours) from the University of London (LSE), an MSc in Finance (Economic Policy) from the University of London (SOAS) and a PhD focusing on sovereign credit ratings from the University of Nottingham.

Dr Runchana Pongsaparn

Dr Runchana Pongsaparn joined the ASEAN+3 Macroeconomic Research Office (AMRO) as Group Head and Principal Economist in 2022, leading macroeconomic and financial system surveillance for Japan, Malaysia, and the Philippines.

Prior to AMRO, Dr Pongsaparn spent 18 years at the Bank of Thailand (BOT) in roles encompassing monetary policy, exchange rate policy, macroeconomic modelling, financial stability, and crisis management. She coordinated BOT's cooperation with international organisations such as the International Monetary Fund (IMF) and the Bank for International Settlements (BIS) and lectured at several Thai universities from 2006 to 2022.

Dr Pongsaparn has also served at the IMF, specialising in monetary policy and financial stability, and acted as an advisor to the National Bank of Cambodia. She holds a Master's degree in Economics from the University of Cambridge, and a PhD in Economics from the University of Bristol.

Amar C. Ramachandran

Amar C. Ramachandran is the Director and Head of Investment at Manulife Insurance Berhad, with 25 years of experience in investment and treasury, particularly in the insurance and contingent liability industry. His background includes seven years at a development financial institution and a stint in investment research.

Since joining Manulife in 2019, Amar has developed alternative investments and private market assets to address low yields and market volatility. He has published and presented research on investment and macro-policy issues in Malaysia.

Amar holds qualifications in accounting and finance and is an Affiliate of the Association of Corporate Treasurers (UK), a Chartered Member of the Chartered Institute for Securities & Investment (UK), a Fellow of the Financial Services Institute of Australasia, and a Fellow of CPA Australia.
